Clarification on Applications for the Post of Clerk 'A' (OBC & Unreserved) and Administrative Assistant – B (Unreserved)

With reference to the advertisement for the post of Clerk 'A' (OBC & Unreserved) on a permanent basis, it is hereby notified that candidates who have submitted applications under both the OBC and Unreserved categories shall have an admit card generated for only one application, preferably under the OBC category.

Candidates shortlisted under the OBC category shall be required to substantiate their eligibility by providing the requisite certificate at the time of verification. Failure to produce the said certificate shall result in the cancellation of their candidature under the OBC category, in which case the application shall be considered under the Unreserved category, subject to fulfillment of eligibility criteria.

Further, in cases where multiple applications have been submitted by the same candidate, only the latest application shall be considered valid for processing.
