Grants for Group Leaders

1. Sustainable crop production research for International Development









UK's Biotechnology and Biological Sciences Research Council (**BBSRC**) and Department for International Development (**DFID**), together with the Bill & Melinda Gates Foundation (**BMGF**), USA, the Department of Biotechnology (**DBT**) and the Indian Council of Agricultural Research (**ICAR**) invite joint call for proposals under the scheme "**Sustainable crop production research for International Development**".

The programme supports high-quality basic and strategic biological and biotechnological research to improve the production of major food crops in developing countries in the sub-Saharan Africa and South Asia by forging scientific partnerships between these countries and UK. The call supports two sub-schemes: **Standard Research Grants** (SRGs) (5 years) and **Projects for Emerging Agricultural Research Leaders** (PEARLs) (4 years). The total funding available for funding both these schemes is £20 M, out of which £2M is allocated for PEARL funding scheme (5-10 in number). Funding from the Government of India will be managed independently by DBT. 2. Indo-Swiss Joint Research Programme- Joint Research Project





Department of Science & Technology

The Swiss National Science Foundation (SNSF) and DST have issued a joint call inviting collaborative projects with clearly defined goals involving at least one Swiss and one Indian partner. The fields of research funded in this round include **nanotechnology and oncology**. The grant is for 36 months and provides funding for personnel, consumables, travel and living expenses for the visiting partner. The total Swiss funding for this project is CHF 2 million. The Indian partner is funded by DST as per their norms. The joint research projects need to be submitted simultaneously to the SNSF and DST by the collaborating partners by **April 30, 2011**. 3. Utrecht University Short Stay Visiting Professorship



The purpose of these fellowships is to strengthen the existing collaboration between the Utrecht University and its partners and to explore and set up cooperation projects in research and/or education. NCBS is a partner of Utrecht University (UU) and therefore eligible to participate in

exchange of professors between the two institutes. Maximum support for a visiting professorship is € 5000 for a stay of at least two weeks in total. Applications are considered from professors in one of the 15 UU Research Focus areas



Fellowships for Junior Researchers

1. DBT-Research Associateship Programme in Biotechnology and Life Sciences (http://sid.iisc.ernet.in/dbtpdf.html)

The purpose of the fellowship programme is to train scientists in frontier areas of research in Biotechnology at institutions in India engaged in major biotechnological research activities. Under this programme, funds are provided for salary support and contingency for a period of 2 years. Only Indian nationals with a Ph.D. degree / M.D. or M.S. degree in any area of medicine with research interests in Biotechnology and Life Sciences, a good academic record and below the age of 40 years (relaxable by 5 years for women) may apply. These fellowships are awarded twice a year. The scheme is administered via the Indian Institute of Science, Bangalore. The coordinator for this programme is **Prof. K. Muniyappa.** The next deadline for submission of applications is **March 20, 2011.**

2. International Brain Research Organization (IBRO)

3. Newton International Fellowships



The Royal society, UK offers the Newton International fellowships to early stage postdocs to enable them to pursue postdoctoral training in UK for 2 years. The Fellowships include £24,000 per annum to cover subsistence and up to £8,000 to cover research expenses, plus a one-off relocation allowance of up to £2,000. Funding, worth £6,000 per year for ten years after the Fellowship ends, may be available to support follow-on activities to enable Newton Fellows to build long-term links with the UK. 4. Ravi Sankaran Fellowship Program



The Inlaks Shivadasani foundation awards Ravi Sankaran Fellowships to support activities that have an explicit focus on biodiversity conservation. These fellowships support internship in an institution abroad or a short conservation research or implementation project within India (in a Small Grants program). Fellowship includes stipend, travel funds and course fees (where relevant). The Small Grants activity provides funding up to a maximum of Rs 200,000 per year. 5. International Neuroscience Fellowship (NIH)



The U.S. National Institutes of Health (NIH) has announced the International Neuroscience Fellowship (INF) to advance the training of qualified foreign neuroscientists and clinicians at the early or midcareer level in a research setting in the United States (U.S.).

All applicants must have a doctoral or equivalent degree, and an endorsement from their home institution, with a guaranteed appointment upon completion of the fellowship. Applicants must have a sponsor in the U.S. who is affiliated with an eligible U.S. organization. **Researchers from India are eligible to apply.** All applications for the INF must be submitted from the U.S. Sponsoring Institution. Applications are due by **August 16, 2011**, by 5:00 PM local time of applicant organization.
