1. <u>Scope:</u>This indent is for supply of HEPA filters for the HVAC systems in National Centre for Biological Sciences (NCBS), GKVK Campus, Bengaluru 560065, as per specifications, Technical terms & conditions given below.

2. <u>Qualification Criteria for Bidders:</u> The original manufacturers of filters or their authorized representatives shall be an established agency for manufacturing/ selling the offered filters with requisite certification (as per Point no 4.2, 4.3). Filter manufacturers shall be required to show evidence that HEPA filter designs have successfully passed the qualification and requalification testing in accordance with standards mentioned in the tender.

4. <u>Testing and Inspection</u>: The following testing and inspection works shall be carried out at the manufacturer's site in the presence of the Indentor (or) his representative for HEPA Filters.

4.1 <u>Flow, Pressure drop & Collection efficiency</u>: Each filter shall be individually tested for its initial pressure drop and collection efficiency at the rated flow, as per the approved test procedure at the manufacturer's site. <u>The test results (air flow, initial pressure drop and collection efficiency)</u>, the airflow direction and the date of testing shall be marked on the filters, after approval and acceptance. Only filters assembled and completed in all respects (without gaskets) with totally cured and dried sealant and of specified dimensions shall be taken up for this performance evaluation.

4.2 The HEPA testing & test set-up should comply to EN 1822 standards. HEPA filters should be tested at the manufacturing unit/Third party testing facility. Testing should be done by a Third party organization which is certified by ISO/IEC 17025/Bureau of Indian Standards/Quality Council of India.

4.3 To prove the above compliances:

a) The quote should accompany the (point 4.3) certificates of already tested HEPA's, or

b) Can get any of the HEPA tested & submit the certificates along with the quote.

#### 4.4 Quotes without the above compliance certificates will be dis-qualified.

4.5 Post the Purchase Order the indentor reserves the right to carry out the qualification tests, at manufacturer's work, on randomly selected filter out of the lot manufactured against the order, if desired viz. for dimension, overall rigidity, air flow capacity and Filter Efficiency at manufacturer's own cost.

5. Testing and Inspection of other filters may also be undertaken, if desired, on one of randomly selected filters, at manufacturer's work & cost. The manufacturer is liable to prove the specifications mentioned as per standard tests and any one of the randomly selected filters fails the test, entire lot may be rejected.

6. <u>Packing</u>: The individual filter shall be packed in a polythene bag and in to a rigid cardboard carton. The filter shall be placed in the carton in such a way that the faces and pleats are vertical when the carton is in the normal shipping orientation. The carton shall be marked as "FRAGILE, HANDLE WITH CARE & THIS SIDE UP" or similar legend. The serial number, dimension and description of the filter packed inside shall also be indicated.

#### 7. Documents To be submitted

#### 7.1 Along with Price Quote:

- a. Requisite valid certification for manufacturing/testing of HEPA as per points 4.2 & 4.3 above.
- b. Filter Specifications wrt the indicated specs above.

#### 7.2 During delivery of material:

a. Valid test certificates as mentioned in Testing & Inspection criteria.

#### MICRO AND SMALL ENTERPRISES (MSES):

1.
