ANNEXURE A – SPECIFICATIONS – 3i Nouveau Phasor Digital Holography System (Upgradation for the existing Microscope)

The latest model 3D holography system should enable precise 3D multipoint pattern generation and arbitrary light patterning for both live and fixed samples in upright system. It should support high-resolution multiphoton imaging, laser photomanipulation, and complex holographic applications. The system must include high-performance components such as a femtosecond laser for fast, accurate excitation, and a sensitive sCMOS camera for image acquisition. Advanced control software should be provided for seamless management of imaging protocols, data processing, and analysis, with capabilities for 3D volume rendering and time-lapse imaging. The platform must also be upgradable to support additional advanced imaging techniques such as light sheet imaging, deconvolution, adaptive optics, and more. This fully integrated system should be suitable for high-speed, high-precision research applications, offering flexibility across a wide range of experimental requirements.

A. 3D Holography system

The holographic system should be a computer-generated holography platform capable of generating simultaneous 3D multipoint and arbitrary patterns. It should support objectives with an 18mm back aperture and be suitable for use with live and fixed biological samples. The system must include a phase-only spatial light modulator (SLM) module for high-precision photomanipulation and pattern control, along with control and analysis software for real-time operations. It should support triggered holography streaming capture for dynamic, fast patterning. The system should require an online software license for live mode and be provided with one SLM module, a scope-specific mounting kit, table mounting kit for stable setup, beam expansion for optimal light manipulation, and power modulation for precise light intensity control.

B. Narrowband SLM for 3D holography system

A narrow band spatial light modulator (SLM) should be provided and optimized for high-power stimulation lasers, operating at a central wavelength of 1050nm with a bandwidth of ± 50 nm. The system should include a narrowband SLM for the sCMOS camera, a controller for precision control of the modulator, and a DisplayPort to DVI cable for display connectivity. A mounting kit should also be provided for proper integration with the microscope setup. The system requires a GPU with an available DisplayPort output for operation.

C. Mounting and Alignment Kit for Multiphoton Upright Microscope

A substage assembly, scope-specific mounting components, a set of output relay lenses, and necessary alignment tools for upright microscope should be provided. It must be compatible with the upright microscope microscope for precise mounting and alignment in multiphoton imaging setups.

D. Beam Steering for Holographic System

The system should include beam steering components designed for the holographic system, allowing precise control and alignment of the laser beam path for accurate pattern generation and imaging.

E. Adapter for Olympus BX51WI

The adapter should include a dual-port intermediate tube and a reflecting dichroic suitable for a 1040nm laser, along with integrated safety filters for the eyepieces to ensure compatibility with laser sources while providing safe observation through the eyepieces.

F. Workstation for multiphoton system

The acquisition workstation should be equipped with a Dell 5860 platform, featuring an Intel Xeon w3-2435 processor with 8 cores and 16 threads, running at 3.1 GHz with a Turbo Boost up to 4.5 GHz, and a 22.5MB cache. It should include a 16GB NVIDIA RTX A4000 GPU for high-performance graphics processing, 64GB of ECC DDR5 4800 MHz RAM for reliable memory performance, and storage consisting of a 1TB M.2 NVMe SSD and an 8TB M.2 NVMe SSD for high-speed data access and large data storage. Networking should be supported via a 10Gb Ethernet connection. The workstation must include an 8x DVD+/-RW drive, a mechanical illuminated keyboard, and a 4-port USB 3.2 PCIe expansion card for additional connectivity. It should operate on Windows 11 Pro and should have a 3-year Dell ProSupport Plus NBD warranty.

Additional modules should be available for applications such as deconvolution, photomanipulation, holography, light sheet imaging, scanning, and adaptive optics.

The vendors should have a good track record of post-sales support with local sales and service and application support at Bangalore (provide details of person in-charge),





WHEREAS the BUYER proposes to procure and the BIDDER/Seller is willing to offer/has offered the stores and WHEREAS the BIDDER is a private company/public company/Government undertaking/partnership/registered export agency, constituted in accordance with the relevant law in the matter and the BUYER is an Autonomous Body/Department of the Government of India performing its functions on behalf of the President of India.

NOW, THEREFORE, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to :-Enabling the BUYER to obtain the desired said stores / equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling BIDDERs to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the BUYER will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

1. Commitments of the BUYER

- 1.1The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favor or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.
- 1.2 The BUYER will, during the pre-contract stage, treat all BIDDERs alike, and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERs.
- 1.3 All the officials of the Buyer will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

3. Commitments of BIDDERs:

- 3. The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following:

- 3.4 BIDDERs shall disclose the payments to be made by them to agents / brokers or any other intermediary, in connection with this bid/contract.

5. SECURITY DEPOSIT /PERFORMANCE GUARANTEE

- 5.1 Performance Guarantee Bond is mandatory.
- 5.2 Successful tenderer/ bidder should submit performance guarantee as prescribed above to be sent to Head, (A&F), NCBS- TIFR on or before 15 days from the due date of issue of order acknowledgement. The PBG to be furnished in the form of bank guarantee as per proforma or annexure of the tender documents, for an amount covering 3 % of the purchase order value.
- 5.3 The Performance Guarantee should be established in favour of "Head, (A & F), NCBS-TIFR, Bangalore.
- 5.4 PBG to be established through any of the National Banks (whether situated at Bangalore or outstation) with a clause to enforced the same on their local branch of Bangalore or any scheduled bank (other than national bank) situated at Bangalore. - 6.2The BUYER will be entitled to take all or any of the actions mentioned at para 7.1(i) to (x) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act 1988 or any other statute enacted for prevention of corruption.
- 6.3 The decision of the BUYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the independent Monitor(s) appointed for the purposes of this Pact.

7. Fall Clause

7.1 The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry / Department of the Government of India or PSU and if it is found at any stage that similar product/system or sub-system was supplied by the BIDDER to any other Ministry/Department of the Government of India or PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.

8. Independent monitors

- 8.1 The BUYER has appointed Independent Monitors (hereinafter referred to as Monitors) for this Pact in consultation with the Central Vigilance Commission (Chief Vigilance Officer, Tata Institute of Fundamental Research, Mumbai).
- 8.2 The task of the Monitor shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact
- 8.3 The Monitor shall not be subject to instructions by the representatives of the parties and performs their functions neutrally and independently.
- 8.4 Both the parties accept that the Monitor have the right to access all the documents relating to the project/procurement, including minutes of the meetings.
- 8.5 As soon as the Monitor notices, or believes to notice, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- 8.6The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the BUYER including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- 8.7 The BUYER will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.

8.8 The Monitor will submit a written report to the designated Authority of BUYER/ Secretary in the Department/within 8 to 10 weeks from the date of reference or intimation to him by the BUYER / BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

9. Facilitation of Investigation

In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information & documents in English and shall extend all possible help for the purpose of such examination.

10. Law and Place of Jurisdiction

This Pact is subject to Indian Law. The place of performance and Jurisdiction is the Seat of the BUYER.

11. Other Legal Actions

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

12. Validity

- 12.1 The validity of this Integrity Pact shall be from date of its signing and extend up to 5 years or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/ Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.
- 12.2 Should one or several provisions of this Pact turn out to be invalid, the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

The Parties hereby sign this Integrity Pact.
