LMLMS000030 Corncob bedding material for laboratory Rats and Mice as per the 85000.00 specifications:-KGS Specifications for corn cob bedding material for rodents (indent #: GHM0010025): 1. Manufacturing unit must be ISO: 9001 and HACCP certified (should allow audit from NCBS scientific team, if required). 2. Bedding material should be of 4-6 mm size uniform granules, free from dust, foreign bodies and autoclavable. 3. Bedding material should not have moisture more than 9% and NOT fungus infested. 4. Packing should be done with double layer, moisture proof HDPE bags with autoclave indicator strips inside each bag (Bags should be autoclave compatible and Max 20kgs capacity). 5. Certificate of analysis should be provided with every fresh batch of material to show that there are no harmful contaminants (listed below). 6. Bedding material should have atleast one year shelf life from the date of packing and every batch of material supplied should not be older than 3 months at the time delivery. 7. Analysis should be carried out for Mycotoxins, Heavy metals, microbial, Chlorinated Hydrocarbons, Phosphoric acid esters, Polychlorinated Biphenyls, Pesticides and Moisture content in the final processed product from a reputed lab. 8. Vendor should have atleast 1-2 years of experience of consistent and satisfactory supply to any reputed animal facilities maintaining Specific Pathogen Free (SPF) rodent colonies. Enclose Last 3 years; Purchase orders references with satisfactory performance certificates from end-users. 9. Suppliers must be able to supply material on staggered basis within a week of phone order on monthly basis requirement (6 to 7 tons/month). 10. Supplier has to take the responsibility of unloading the material to animal

10. Supplier has to take the responsibility of unloading the material to animal facility store room in the basement floor.

11. If any batch of material is rejected for contamination or deviation in specification, it must be

taken back and replaced free of cost within a week time.
