NOTE:

1. The quotations must be submitted in a sealed envelope duly mentioning in the Notice Inviting Quotation number and Name of the work.
2. Time is the essence of the contract.
3. The Earnest Money Deposit (EMD) indicated above shall be drawn in favour of National Centre for Biological Sciences, Bangalore and shall be enclosed to the tender. If the EMD is not enclosed, the offer will be summarily rejected.
4. The Contractors whose tender/s is/are accepted will be required to furnish Security Deposit/s (Including the Earnest Money Deposit/s) and performance guarantee for the due fulfillment of the contract/s as per details in clauses 1 and 1A of the conditions of Contract.
5. A Security Deposit at the rate of 2.5% of the value of work done will be deducted from the bills. The Security Deposit so recovered shall be released after the expiry of the defects liability period of 6 months from the date of completion of work as recorded by Engineer-In-Charge.
6. Contractors may please note that they shall follow the safety and security procedures while at work in NCBS as per the Institute's norms.
7. Contractors may please note that the work should be executed as per the standard specification and the measurements shall be recorded accordingly.
8. The work shall be carried out as per standard specifications of CPWD / relevant IS code if the CPWD specifications are silent and also as per manufacturers specifications as directed by Engineer - In - Charge.
9. If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the expiry of the contract he shall on account of such breach, pay agreed compensation as per clause 2 of GCC-CPWD 2022.
10. NCBS does not bind itself to accept the lowest or any other quotation, and reserves the authority to reject any or all of the quotations or to allot parts of the works to different agencies without assigning any reason thereof. All quotations, in which any of the prescribed conditions is not fulfilled or the agencies put any condition, not acceptable to NCBS, including that of conditional rebate is liable to be summarily rejected.
