General Configuration:

Biocontainment Individually Ventilated Caging (IVC) System should be designed and manufactured according to international standards with consideration of biosafety and biocontainment principles to use at animal biosafety level-3 (ABSL-3) laboratory facility. All components of the IVC system should be autoclavable (except digital units), and every cage of the system should act as an isolator. A standalone AHU unit with a digital display for all the air handling parameters should be included in the cumulative IVC system. The racks should be connected to the AHU through suitable ducts/plenum for both supply and exhaust to achieve the optimal negative pressure model. The AHU of the IVC unit should be enabled with appropriate HEPA (H14) / ULPA (U15) / equivalent filtration with valid certifications for both supply and exhaust and the exhaust air filtration should occur from cage level is essential. In addition, a separate ducting kit should be included along with the AHU unit where the exhaust line of the IVC unit can be connected to the laboratory room exhaust. The required IVC rack should be made up of stainless-steel material and a requirement is a single-sided unit with the capacity to hold a maximum of 36-48 cages. The cages should be made up of durable and transparent autoclavable plastics with a minimum 3 years warranty.

In addition, the negative pressure balance inside the cages should be maintained optimally. The certification and third-party validation are mandatory for the same.
 The height of the rack should not be more than 8 feet.
- 5. The footprint of the rack should not be more than 6 X 2 feet.
- 6. The plenums of the rack should be cylindrical to get equal air distribution for both supply and exhaust.
- Rack should have a cage self-locking system and visual indicators for appropriate assembly of cages into rack slots and the supply nozzle.

3 Air Handling Unit (AHU):

- AHU of the IVC unit should be a stand-alone unit either on wheels with brakes or detachable to position in stable locations.
- 2. AHU width should not be more than 13 inches.
- 3. AHU with ECM-DC motors along with a standby must ensure consumption of very low power and low heat loss with consequent low running costs. The optimal power supply to the AHU should be 220-230V 50Hz and the standby UPS system (with the backup of at least 12 hours) should be enabled within the system is essential. In addition, the maximum power requirement for the AHU needs to be indicated.
- 4. AHU Should comprise the HEPA (H14) / ULPA (U15) filters for the supply and exhaust.
- 5. The AHU should supply the maximum air changes per hour / ACPH (desired air changes is 70-80).
- 6. Air handling parameters such as temperature, humidity and pressure should be controlled by a microprocessor-based central control system with a standby digital display for the ongoing parameters. In addition, the system should support any updates in the program/software.
- The system should indicate the failures of power and physical sensors such as temperature, humidity and pressure in the provided display along with an audible alarm.
- 8. Exhaust air from AHU must be connected to room exhaust; a separate plenum kit should be supplied for the same.
- 9. AHU should have a monitoring device to assess the status of the filters.
- 10. AHUs should not transmit any vibration to the connected racks.
- 11. Noise level of AHU should not be more than 50db.

5 Certifications:
